## Message from the Board Chair

Dear Friends of ProMusica Arizona,

The last year has been challenging for ProMusica Arizona as it has been for so many organizations and individuals. Our entire 2020-21 season was impacted by the COVID pandemic, requiring us to reimagine ways to involve our musicians, engage our audience, and stay financially sound.

With all hopes for a typical performance year eliminated by the continued restrictions on in-person gatherings, we programmed virtual content as a substitute. We offered online chorale and instrumental techniques classes that gave musicians an opportunity to build their skill level with professional instruction. Participants included not only our own singers and instrumentalists, but also international students from as far away as Australia.

For our patrons, we presented two free online concerts featuring small, socially distanced ensembles. *A Musical Kaleidoscope* was performed in November and *A Christmas Kaleidoscope* was performed in December. Both were live-streamed and recorded so they could be enjoyed during the actual performance or at another convenient time.

Virtual attendance was outstanding, and the concerts were viewed by audiences all over the United States including senior communities that presented them as special events to their residents.

With some of our usual revenue streams diminished, we explored alternative ways to remain financially solvent. ProMusica Arizona had no ticket revenue during the 2020-21 season, and we were sensitive to the fact that donors may have limited resources and other giving priorities through the pandemic. So, we did not have our usual Spring Campaign, and, due to COVID restrictions, we were unable to hold our Musical Champagne Salon fundraiser.

However, we were supported by a forgivable Payroll Protection Program loan from the federal government; grants from the Small Business Administration, Arizona Commission on the Arts, Maricopa County, City of Peoria, Unity of Phoenix Spiritual Center, and Arizona Choral Directors Association; concert sponsorships from Anthem Law and Andrew Z Diamonds & Fine Jewelry; donations from more than 100 individuals; and corporate contributions from Pfizer Foundation, American Express, Cisco, Kroger, and Amazon Smile. The generous support of these grant funders and individual donors allowed us to retain our employees, support our essential contractors, and continue planning for the future despite loss of concert revenue.

Overall revenue was down considerably for the year, but there was a corresponding drop in expenses allowing ProMusica Arizona to finish the year with sufficient money in the bank to begin to replenish reserves and provide operating revenue for the first quarter of fiscal year 2021-22.

Additionally, we formed a committee that established the ProMusica Arizona Endowment Fund to provide long-term financial resources to support continued excellence in live vocal and instrumental performances. Marketing efforts to encourage legacy giving will begin in the Fall of 2021.

Current plans call for an in-person three-concert season for 2021-22. Our singers and instrumentalists are looking forward to singing and playing for a live audience again!

It has been my privilege to serve as the Board Chair for the last three seasons. We've certainly seen challenges, but I'm very proud of our team of Board members, musicians, staff, and volunteers that has worked together and come through stronger. I would especially like to thank Yvonne Dolby, Patti Graetz, and Meghan Ruel for their tireless dedication to ProMusica Arizona throughout the year.

Finally, I am happy to announce our new Board Chair, Malcolm Smith. Malcolm has played cello in our orchestra for many years and served as a Board member. I know ProMusica Arizona will thrive in his capable hands.

Thank you to everyone who has continued to support us through your concert attendance and financial contributions! I look forward to seeing you in-person soon!



Screenshots from November 2020 virtual concert


